SECOND AMENDMENT TO DECLARATION OF RESTRICTIVE COVENANTS FOR THE PLAT OF SOMERSET NO. 14

The Plat of Somerset No. 14 (the "Plat") was established by a plat recorded in Vol. 74 of Plats, Pgs. 30 and 31, King County. A declaration of Restrictive Covenants for the Plat of Somerset No. 14 (the "Covenants") was recorded under King County Recording No. 5695892.
