SECOND AMENDMENT TO DECLARATION OF RESTRICTIVE COVENANTS FOR THE PLAT OF SOMERSET NO. 2

The Plat of Somerset No. 2 (the "Plat") was established by a plat recorded in Vol. 68 of Plats, Page 44, King County. A declaration of Restrictive Covenants for the Plat of Somerset No. 2 (the "Covenants") was recorded under King County Recording No. 5389232.
