SECOND AMENDMENT TO DECLARATION OF RESTRICTIVE COVENANTS FOR THE PLAT OF SOMERSET NO. 8

The Plat of Somerset No. 8 (the "Plat") was established by a plat recorded in Vol. 69 of Plats, Pgs. 98, 99 and 100, King County.
