SECOND AMENDMENT TO DECLARATION OF RESTRICTIVE COVENANTS FOR THE PLAT OF SOMERSET NO. 9

The Plat of Somerset No. 9 (the "Plat") was established by a plat recorded in Vol. 74 of Plats, Pg. 16, King County.
