SECOND AMENDMENT TO DECLARATION OF RESTRICTIVE COVENANTS FOR THE PLAT OF SOMERSET HIGHLANDS 1

The Plat of Somerset Highlands 1 (the "Plat") was established by a plat recorded in Vol. 81 of Plats, Pgs. 32, 33 and 34, King County.
